5. Each person whose security interest is recorded with the appropriate public office under the Federal Aviation Act (if the property is an aircraft or part of an aircraft).
6. Each person with a known security interest in the property.
7. Each victim of the crime.
8. If personal property is seized, the seizing agency shall immediately notify the prosecuting attorney, or the attorney general, if the attorney general's office is actively handling the case.
