School Tours

- All tours are guided; reservations required
- Groups up to 48, including chaperones
- Weekdays, 9 a.m.–4 p.m., except court holidays
- 60 minutes (center) or 90 minutes (with Supreme Court courtroom)

Available throughout the year, tours are docent-led, interactive, grade specific, and free of charge. Tours connect to curriculum and help students better understand the role and responsibilities of the judicial branch of government.

- Three branches of government and the powers of the judicial branch
- U.S. Constitution and Michigan Constitution
- Rights and responsibilities of citizens



Visitors learn that everyone has a role in the courtroom, including the judge, attorneys, jurors, witnesses, and the public.

Michigan Supreme Court Courtroom

To include the Michigan Supreme Court courtroom in your visit, you must request this specifically when making a tour reservation. An additional 15–30 minutes is required. Because of the Court's schedule, courtroom visits cannot be guaranteed.



The Hall of Justice is the headquarters of the state's judicial branch of government. It houses the Michigan Supreme Court (shown) and the Court of Appeals – District IV.



Annual Programs & Events

Law Day

The beginning of May features Law Day, a national day set aside to celebrate the rule of law. Activities vary, depending on the national theme. Past events have examined juries, freedom of speech, separation of powers, and voting.



Summer Moot Court

This experience is for high school students interested in legal careers. Students argue a case as if before the Supreme Court. They meet with law students, lawyers, court staff, and members of the judiciary to prepare. Applications available in March.



Constitution Day

On or around September 17 the Learning Center celebrates the signing of the U.S. Constitution in 1787. Events include Constitution-themed tours at the Hall of Justice and virtual options.
