The parties also acknowledge that the Court has the option, after considering numerous mitigating factors set forth in *Miller v Alabama*, 567 US 460, 480; 132 S Ct 2455; 183 L Ed 2d 407 (2012), to either affirm Defendant's non-parolable life sentence or impose a term of years pursuant to MCL 769.25a—"which the maximum term shall be not less than 60 years and the minimum term shall be not less than 25 years or more than 40 years."

Understanding the requirements of the law and the rights afforded to both the Defendant and the victim(s), the parties announce that they have reached a sentence agreement. This agreement comes after full consideration of the record, including the exhibits provided by the defense in preparation for resentencing, and after discussions between Defendant and his attorney and the victim's family and the attorney for the People.



Let me tell you about my son. He was 17 years old, bright (he was in high school) and kind. Not a troublemaker and non-confrontational. There is not one person that I know that would say a bad thing about him. If trouble were to occur, Christopher would leave.

This is how Neilly, Brown, Burnett and Wogoman killed Christopher. They pulled out guns, a 9MM and 357 Magnum and they shot him in the back as he tried to leave in his vehicle. The bullet went through the back seat and pierced his heart.

This is how Christopher's death affected me. When they took Christopher they took part of me. There is not a day that goes by that I do not think about Chris. Ten years has passed and it seems like yesterday, the pain of losing Chris has been the worst fate for me. It is a terrible pain for a mother to suffer when a child dies before her. I celebrate holidays and Christopher's birthday by visiting his grave and leafing through baby pictures and other awards and family photos. Wondering what if he had the opportunity to go to college, what profession would he have chosen? would he be married now and have children because he would be 27? I have been robbed of what a mother always hopes to have. Sharing Mother's day, Christmas, Thanksgiving and birthdays with her children's family and being a grandparent. But these celebrations will not happen. All I have to look forward to is meeting Chris again when I walk through the gates of Heaven.



PER CURIAM.

Defendant appeals as of right the trial court’s imposition of restitution at resentencing. We affirm.

In 1993, defendant, along with three other individuals, was involved in the robbery and shooting death of a 17-year-old individual. Defendant was convicted of first-degree felony murder, conspiracy to commit armed robbery, and possession of a firearm during the commission of a felony. Defendant, who was 17 years old at the time of the offense, was sentenced to life imprisonment without the possibility of parole for the first-degree felony-murder conviction. Defendant was not ordered to pay restitution.

Following the United States’ Supreme Court’s decision in *Miller v Alabama*, 567 US 460; 132 S Ct 2455; 183 L Ed 2d 407 (2012) and the enactment of MCL 769.25a, defendant was set to be resentenced for the first-degree felony-murder conviction. Defendant and the prosecution agreed to a sentence of 35 to 60 years’ imprisonment for the felony-murder and conspiracy convictions. Before the resentencing hearing was held, the victim’s mother requested that

defendant pay restitution of \$14,895.78 for funeral expenses. At the conclusion of the hearing, the trial court ordered that defendant pay restitution in the amount requested.

On appeal, defendant argues that the imposition of restitution at resentencing was a violation of the Ex Post Facto Clause of the Michigan<sup>1</sup> and United States<sup>2</sup> Constitutions because defendant was sentenced under the current version of the restitution statutes, and not the version of those statutes that was in effect at the time of defendant's original sentencing in 1993. We disagree.

Generally, we review an order of restitution for an abuse of discretion. *People v Gubachy*, 272 Mich App 706, 708; 728 NW2d 891 (2006). "[W]hen the determination of restitution involves statutory interpretation, the review is de novo." *People v Byard*, 265 Mich App 510, 511; 696 NW2d 783 (2005). We review constitutional questions de novo. *People v Lockridge*, 498 Mich 358, 373; 870 NW2d 502 (2015).

An order of restitution is governed in part by MCL 780.766(2). The current version of MCL 780.766(2) states as follows:

Except as provided in subsection (8), when sentencing a defendant convicted of a crime, the court shall order, in addition to or in lieu of any other penalty authorized by law or in addition to any other penalty required by law, that the defendant make full restitution to any victim of the defendant's course of conduct that gives rise to the conviction or to the victim's estate.<sup>[3]</sup>

In 1993, this statute was largely the same, except that it provided that the trial court *may* order restitution, instead of requiring the trial court to order restitution. MCL 780.766(2), as amended by 1988 PA 21.

Additionally, in the 1993 version of MCL 780.767(1), the trial court was required to consider the financial resources and earning ability of the defendant when determining whether to order restitution and the amount of that restitution. MCL 780.767(1), as amended by 1985 PA 87. That consideration is not included in the current version of MCL 780.767(1). In the current version, the trial court is only instructed to consider the amount of loss sustained by the victim when determining the amount of restitution. MCL 780.767(1).

For the application of a criminal or penal law to violate the Ex Post Facto Clause of the Michigan or United States Constitutions, two elements must be present: “it must be retrospective, that is, it must apply to events occurring before its enactment, and it must disadvantage the offender affected by it.” *Weaver v Graham*, 450 US 24, 29; 101 S Ct 960; 67 L Ed 2d 17 (1981). However, a statute does not violate the Ex Post Facto Clause of either the United States or Michigan Constitutions unless, among other things, the law increases the punishment for a crime.<sup>4</sup> *People v Earl*, 495 Mich 33, 37; 845 NW2d 721 (2014); see also *Weaver*, 450 US at 29 n 12. The Supreme Court enumerated a two-step analysis for determining whether a law is a “punishment” and, therefore, is capable of violating the Ex Post Facto Clause:

The court must begin by determining whether the Legislature intended the statute as a criminal punishment or a civil remedy. If the Legislature’s intention was to impose a criminal punishment, retroactive application of the law violates the Ex Post Facto Clause and the analysis is over. However, if the Legislature intended to enact a civil remedy, the court must also ascertain whether the statutory scheme is so punitive either in purpose or effect as to negate the State’s intention to deem it civil. Stated another way, even if the text of the statute indicates the Legislature’s intent to impose a civil remedy, we must determine whether the statute nevertheless functions as a criminal punishment in application. [*Earl*, 495 Mich at 38 (quotation marks and citations omitted).]

However, if this Court determines that the legislative intent was to impose a civil penalty, then the statute will be deemed to be a punishment only if the defendant shows by “the clearest proof” that the statute is so punitive either in purpose or effect so as the statute functions as a criminal penalty. *People v Betts*, 507 Mich 527, 543-544; 968 NW2d 497 (2021).

There is conflicting authority regarding whether the purpose of restitution was to serve as a punishment. This Court has held that the purpose of restitution is to compensate the injured party. *People v Schluter*, 204 Mich App 60, 63; 514 NW2d 489 (1994). But this Court also concluded on the basis of the language of MCL 780.766(2) that restitution is part of the penalty imposed by the trial court. *Id.* at 65. In the context of determining whether restitution violated a defendant’s protection against double jeopardy, this Court held that “the trial court’s order of restitution was not in excess of the punishment intended by the Legislature.” *People v Dewald*, 267 Mich App 365, 385; 705 NW2d 167 (2005). The Michigan Supreme Court has held that, although the defendant argued that a restitution order was a penalty because it forced him to pay a large sum of money, the fact that the restitution order would cause the defendant financial pain did not “automatically render the order primarily penal.” *People v Peters*, 449 Mich 515, 523, 526; 537 NW2d 160 (1995).

<sup>4</sup> Other instances in which a law can be found to violate the Ex Post Facto Clause are when it “(1) punishes an act that was innocent when the act was committed; (2) makes an act a more serious criminal offense; . . . or (4) allows the prosecution to convict on less evidence.” *Earl*, 495 Mich at 37. Those instances are not applicable to this case.

In a recent opinion, this Court noted that it “has consistently held that the focus of restitution is on the victims’ losses not on punishing criminal defendants” and that restitution was remedial in its character. *People v Foster*, 319 Mich App 365, 389; 901 NW2d 127 (2017); see also *People v Allen*, 295 Mich App 277, 282; 813 NW2d 806 (2011) (holding that the legislative intent of the Victim’s Rights Act was to shift the burden of losses arising from criminal conduct to the defendants, and that the law was “remedial in character . . .”). This Court has also stated that “the purpose of restitution is to allow crime victims to recoup losses suffered as a result of criminal conduct.” *People v Newton*, 257 Mich App 61, 68; 665 NW2d 504 (2003).

This Court has also explicitly stated that “a restitution order is not a penalty.” *Foster*, 319 Mich App at 389. This Court made these statements in the context of analyzing whether a restitution order violated the Sixth Amendment requirement that any fact that increases the penalty for a crime beyond the prescribed statutory maximum be submitted to a jury and proved beyond a reasonable doubt. *Id.* at 388, 389.

Although there is some conflicting authority on this issue, the weight of the authority establishes that this Court treats the primary intention of the Legislature in enacting the restitution statute to be compensating crime victims. *Foster*, 319 Mich App at 389; *Allen*, 295 Mich App at 282; *Newton*, 257 Mich App at 68; *Schluter*, 204 Mich App at 63. Therefore, we conclude that the Legislature did not intend for the restitution statutes to be a criminal punishment. See *Earl*, 495 Mich at 38.

We must next determine if, nevertheless, the statute functions as a criminal punishment in application. *Earl*, 495 Mich at 38. The United States Supreme Court enumerated the following factors when making this determination (the *Mendoza-Martinez* factors):

Whether the sanction involves an affirmative disability or restraint, whether it has historically been regarded as a punishment, whether it comes into play only on a finding of scienter, whether its operation will promote the traditional aims of punishment—retribution and deterrence, whether the behavior to which it applies is already a crime, whether an alternative purpose to which it may rationally be connected is assignable for it, and whether it appears excessive in relation to the alternative purpose assigned. [*Kennedy v Mendoza-Martinez*, 372 US 144, 168-169; 83 S Ct 554; 9 L Ed 2d 644 (1963); see also *Betts*, 507 Mich at 545.]

Some of the *Mendoza-Martinez* factors suggest that restitution is a penalty. It could be said that the operation of the restitution statute will promote the traditional aims of punishment—retribution and deterrence. See *Earl*, 495 Mich at 38. But several other *Mendoza-Martinez* factors suggest that restitution is not a punishment. Restitution does not involve an affirmative disability or restraint, defendant has not provided any evidence that restitution had historically been regarded as a punishment, restitution does not come into play only on a finding of scienter, there is an alternative purpose to which restitution may rationally be connected, and restitution is not excessive in relation to that alternative purpose. See *Mendoza-Martinez*, 372 US at 168-169. Therefore, there is not “the clearest proof” that, despite the Legislature’s intent, restitution functions as a penalty. See *Betts*, 507 Mich at 543-544.

Because restitution is not a penalty under the legislative intent or in its application, it cannot violate the Ex Post Facto Clause as the application of the current version of the statute does not increase the punishment for a crime. See *Earl*, 495 Mich at 37.

Affirmed.

It is respectfully recommended that the Defendant be sentenced to a 40 to 60 year prison term with the Michigan Department of Corrections. He is entitled to jail credit of 9446 days served at sentencing on 04/22/2021. This sentence is to be served consecutive to a prison term imposed in Count II, and concurrent with all other counts.

**Count II-Weapons-Felony Firearms**

It is respectfully recommended that the Defendant be sentenced to a 2-year prison term with the Michigan Department of Corrections. He is entitled to jail credit of 730 days served at sentencing on 04/21/2021. This sentence is to be served preceding and consecutive to the prison term imposed in Count I, and concurrent with all other counts.

**Count V-Robbery Armed (Conspiracy)**

It is respectfully recommended that the Defendant be sentenced to a 40 to 60 year prison term with the Michigan Department of Corrections. He is entitled to jail credit of 9446 days served at sentencing on 04/22/2021. This sentence is to be served consecutive to a prison term imposed in Count VI, and concurrent with all other counts.

**Evaluation and Plan**

On or about 06/23/1993, the Defendant, along with codefendants Donnie Wogoman, Angelo Burnett and James Brown, conspired to rob Christopher Ricketts, of his car stereo. The Defendant, along with codefendant Brown, approached the victim's car, armed with handguns. When the victim attempted to leave, both individuals fired into the vehicle, with a bullet striking the victim, causing his death.

The Defendant was originally charged with Felony Murder, Assault to Rob While Armed, Conspiracy to Commit Armed Robbery and three counts of Felony Firearm. On 11/08/1993, he was convicted by jury trial of Felony Murder, Conspiracy to Commit Armed Robbery and two counts of Felony Firearm. He was sentenced to prison with the Michigan Department of Corrections on 11/29/1993.

The Defendant is a forty-four year old man, before the court for re-sentencing on crimes he was sentenced to in 1993. He was sentenced to life in prison for murder and robbery charges and two year prison terms for the Felony Firearm offenses. There are six factors the court must consider in regard to resentencing. First factor is the Defendant's age at the time of the offense. The Defendant was seventeen years old when he committed the instant offense and was under active juvenile court supervision. Second, the court must consider the hallmark features of youth, such as immaturity, impetuosity and failure to appreciate risk and consequences. There is ample evidence to suggest the Defendant was fully aware of the risk and consequences of his actions, given his statements at the time of the offense, as well as subsequent statements. His actions can also be associated with his mental immaturity and his desire to act tough in front of his peers. The third factor is the offender's family and home environment. By all accounts, the Defendant's home environment could be classified as less than ideal. The majority of his siblings, as well as his mother, possess criminal records. His father was not a factor in his upbringing and male role models were all involved in the drug/crime culture, which he tried to emulate. Records also suggest a lack of discipline, structure and proper guidance in the family home. The Defendant's grandmother appears to be the only positive influence in the Defendant's life. The fourth factor that needs to be considered are the circumstances of the offense, including the extent of the Defendant's participation and peer/family influence. The offense involved the Defendant making a conscience choice to arm himself with a deadly weapon, approach a vehicle and demand the victim turn over his sound system. When the victim chose to flee, both the Defendant and codefendant Brown fired shots into the vehicle. As the Defendant was with several of his friends at the time, peer influence cannot be discounted as a factor, and as stated earlier, family influence in regard to criminal behavior being the norm, is also a likely influence. The fifth factor is whether the Defendant's youth affected how his case was managed by police or the prosecuting attorney. Although the Defendant was seventeen years of age at the time and fled the scene, he did turn himself in at the behest of his grandmother. Charges brought by the prosecutor's office are in line with charges brought against his codefendants. The sixth factor to consider is the possibility of rehabilitation. The Defendant has been incarcerated since 1993. Although he has incurred a number of violations since being incarcerated, the last violation on record was in 2015 and the one prior to that was 2003. He has been assigned as a unit porter since

2013 and has completed a number of programs to include cognitive behavioral, substance abuse and employability skills. He has received positive reports from MDOC staff.

Codefendant Wogoman is serving a life prison term with the Michigan Department of Corrections. Codefendant Brown is serving a life prison term with the Michigan Department of Corrections, and codefendant Burnett was convicted of the lesser charge Assault to Rob While Armed. He was sentenced to fifteen to thirty year prison term and completed his sentence on parole in December 2017. There is no record of a restitution requests in the Defendant's file.

Positive attributes for the Defendant would include his willingness to take full responsibility for his actions in regard to the offense. He has completed his education requirements, as well as multiple programs offered by the Michigan Department of Corrections. He is not seen as a problem inmate and is gainfully employed as a unit porter.

Negative attributes would include negative family influences, past use of alcohol and marijuana, and the fact he was under juvenile court supervision for a felony offense at the time he committed this offense.

A COMPAS screen was completed, indicating several needs. The Defendant is likely to need assistance with housing and employment. Family contacts should be monitored and limited, and the Defendant's proposed placement will also need to be address prior to his release. Addiction issues were noted however, those are based on his behavior when he was seventeen years of age. Controlled substance use has not been noted since incarceration. Cognitive behavior issues were not evident, nor were there indications of mental health issues.

Defendant's social security number was verified using prison case files. One of his proposed placements is with his grandmother in Kalamazoo. It is not known if any of the Defendant's siblings or his mother currently reside there. However, it is the family home and not likely to be the best environment for the Defendant to return to if granted parole. Defendant did indicate that a possible parole placement, who he plans to reside with if he is paroled, would be with his cousin Tony Hill. The address is 2210 Matthew Place, Zion, IL 60099. Commercial placement is also available for the Defendant.

The Defendant does not qualify for SAI, Swift and Sure Sanctions or the Drug Treatment Court Program. He does qualify for residential placement at KPEP.

Taking into consideration the Defendant's age at the time of the offense, as well as his actions, a prison term of forty to sixty years is appropriate and will be recommended. The Defendant has made substantial progress while incarcerated. He has completed multiple programs; his record is void of any misconducts since one in 2015 (and 2003 prior to that) and he takes full responsibility for his actions in regard to this offense. Prison reports are supporting of the Defendant and his psychological assessment does not suggest he suffers from any debilitating mental health issues that would interfere with his reentry into society. However, this agent must also recognize the Defendant's actions resulted in the loss of an innocent life. \*The guns were not received it was unknown which gun caused the fatality. (Per PL 4/21/21) Most troubling, is the fact the Defendant had a total disregard for human life. He, by his own admission, was high and intoxicated and chose to arm himself with a deadly weapon in order to be seen as tough and to show off. He blindly fired into the victim's vehicle, knowing the possible deadly consequences his actions may have on a young man who was doing nothing but sitting in his car. Regardless of the progress the Defendant has made over the years, because of his senseless taking of a life, substantial incarceration is still warranted.

**Agent's Description of the Offense**

The following information was taken from Kalamazoo Department of Public Safety report 93-12965.

On or about 06/10/1993, Kalamazoo Department of Public Safety was dispatched to the 800 block of Hawley St. reference a shooting. Arriving on the scene, officers were directed to a vehicle that had struck a telephone pole. That vehicle was occupied by a lone individual who was slumped over the wheel. Officers observed the man suffer from a bullet wound in the back and was not responsive. LIFE EMS transported the victim to Bronson Hospital where he was pronounced dead from a single gunshot wound to his back, which had caused damage to the victim's heart, lungs and spleen. The victim was identified as Christopher Ricketts, seventeen years of age.

Officers interviewed several witnesses who were at the scene who advised that the victim was killed during a robbery attempt. According to witnesses, Ricketts was sitting in his parked car talking to other people when another vehicle drove up, occupied by William Neilly, James Brown, Angelo Burnett, Donnie Wogoman and Telly Matthews. Those individuals decided to steal the sound system from the victim at that time. Neilly and Brown armed themselves with automatic pistols, walked up to the victim's vehicle and demanded he give them the sound system. He tried to drive away, however, both individuals fired a single shot into the vehicle, with one of those bullets striking the victim in the back, causing the fatal wound.

The suspects all fled the scene at that time and were arrested on felony charges at a later date.

The Defendant was arrested on 06/11/1993 and convicted by jury trial on 11/08/1993. The Defendant was sentenced on 11/29/1993 and remains incarcerated.

**Consecutive Sentences**

Count I must be served preceding and consecutive to any term of imprisonment imposed for the felony contained in Count II. Count VI must be served preceding and consecutive to any term of imprisonment imposed for the felony contained in Count V.

**Victim's Impact Statement**

Original statement from the victim's family is available for the courts review. According to the prosecuting attorney, the victim's family has not supplied any additional statements regarding this offense.

**Defendant's Description of the Offense**

The Defendant was interviewed at the county jail on 11/19/1993 and stated that he was smoking marijuana and drinking at the time of the offense. He advised he was hanging out with the codefendants when they decided that they would steal a car stereo from the victim. He states that he got his 9mm pistol out of the glove box which he had bought for \$50 on the street. He stated \*he was unaware\* (Per PL 4/21/21) Brown got a pistol which was a .380 caliber semi-automatic. They then walked up to the victim's vehicle and he thinks that is when the victim saw him holding a gun and attempted to pull away. Both him and Brown fired a shot into the vehicle and got scared and took off running. He stated that it all started as a joke, became a robbery, and ended in a tragedy and he is sorry for his actions. He does not believe it would have happened if he had not been drinking or high. The Defendant was also interviewed while incarcerated with the Michigan Department of Corrections and supplied a written statement for the court's review. Please see below.

"I take full responsibility for the murder of Christopher Ricketts. I conspired to rob Christopher. I walked to the car, I told him to get out of the car, and as he drove away, I fired. I'm sorry. I'm sorry for killing Christopher and

for the pain that I caused his family and the community. I ask his family for forgiveness. Not only did I rob him of his life but I robbed him of going to college, having a wife and a family. I seek the forgiveness of his family and the community and I want them to know that I am truly sorry for the role that I played that night on June 10, 1993."

SUMMARY:

On the night of 6/10/93, William Neilly conspired with James Brown, Angelo Burnett, and Donnie Wogoman to rob 17-year old Christopher Ricketts. During the course of the hold-up, Ricketts was shot and killed.

EVALUATION AND PLAN:

William Edward Neilly is 17-years old and single. At the time of this offense, he had just completed the school year and he did not have a job. Neilly was born out of wedlock in Kalamazoo on 5/31/76. According to respondent, his father is Billy Gavan. According to Neilly's juvenile file, the father is Eddie Gavan. Whatever the case, Neilly states his father had nothing to do with his upbringing. Respondent was raised on Kalamazoo's east side by his mother, Willie Mae Neilly and his maternal grandmother, Mammie Burnett. Neilly has three older and two younger half siblings. Neilly feels he had a good home life and states he was never neglected or abused. One must assume that moral standards in the household were low as respondent's mother and two of his older half brothers have felony records. At the time of instant offense, Neilly was still living at home. He has never been married, he has no children and no one is pregnant.

Neilly attended Kalamazoo Public Schools. When he got into high school, he skipped a great deal and did poorly academically. After being placed on juvenile probation, he was taken out of regular high school and placed in the Intensive Learning Center. Apparently he did well there. Respondent had just completed the school year at I.L.C. on the day of the murder. Neilly had planned to return to Kalamazoo Central for his junior year in the Fall of 1993. Respondent states he can read and write. He has never been in the Service.

Neilly has never had a regular job. At the time of this offense, he was supported by his mother. In the past, he has had some work experience during the summers with the Y.O.U. Program and at the Juvenile Facility's Intensive Learning Center. Neilly has no marketable job skills. He is indigent.

Respondent states he is in good physical health and feels he is emotionally stable. Other than routine contacts in the juvenile system, he has not been involved in psychiatric care. Neilly states he began drinking and smoking marijuana at age 13. He continued both until the date of instant offense. While in the juvenile system, Neilly used marijuana regularly, had lots of dirty urines, and was sent to Gateway for drug counseling. He continued to use the drug. In the hours preceding instant offense, Neilly states he drank Cognac and smoked marijuana.



Evaluation and Plan cont'd...

If he had not been drunk and high, Neilly feels he would not find himself in this predicament.

Neilly has a juvenile record for Possession of Controlled Substance less than 25 grams. When he committed this offense, he was still on juvenile probation. As for sentencing in these matters, Life in Prison without Parole is the mandatory sentence for First Degree Murder. If commutation is considered at some point in the future, officials should be aware that this murder sparked community outrage and revulsion. The victim was a 17-year old innocent who was minding his own business when set upon by a gang of predatory thugs. This crime is as pointless and mindless as it is violent.

INVESTIGATOR'S VERSION OF THE OFFENSE:

At 10:50 p.m., Thursday, 6/10/93, Kalamazoo Department of Public Safety responded to a shooting in the 800 block of Hawley Street near Cadillac. When they arrived, police found 17-year old Christopher Douglas Ricketts slumped over the wheel of his GEO Tracker. The victim had a single gunshot wound to his back. Ricketts was rushed to Bronson's Hospital where he was pronounced dead at 11:19 p.m. An autopsy was performed the next day and death was attributed to a gunshot wound with resultant trauma to the victim's heart, lungs and spleen.

Witnesses told police that Ricketts was killed during a robbery attempt. The assailants were identified as 17-year old William Neilly, 18-year old James Brown, 19-year old Angelo Burnett, and 19-year old Donnie Wogoman. Apparently, none of the four knew the deceased before they encountered him that night.

In the minutes proceeding the robbery and shooting, Ricketts was sitting in his parked car on Hawley Street talking to other young people. The four attackers then drove up in a car driven by a fifth individual, Telly Matthews.

Ricketts was playing music on his car stereo. Apparently the four decided on the spur of the moment, to steal the sound system. According to police, Neilly and Brown armed themselves with automatic pistols and walked up to Rickett's vehicle. Neilly had his own pistol and was wearing a hooded sweatshirt. Apparently, Wogoman gave Brown a pistol and Burnett gave him a hooded sweatshirt to wear.

Investigator's Version of the Offense Cont'd...

When Neilly and Brown confronted Ricketts, the victim tried to drive away. Both robbers fired a single shot each. A 9mm bullet struck the speaker box and vehicle. A .380 bullet hit the victim in the back and caused the fatal wound. After being shot, the victim's car traveled up Hawley Street and came to a rest when it hit a utility pole on North Street. That is where police found the Rickett's youth. After the abortive robbery attempt and shooting, the assailant fled the scene and disposed of the guns. Neilly, Burnett, and Wogoman were arrested within hours. Brown fled Michigan to California and was arrested later.

Neilly was arrested 6/11/93 and charged with First Degree Murder, Assault w/i to Rob while Armed, Conspiracy to Commit Armed Robbery, and three counts of Felony Firearm. On 11/8/93, he was convicted of all six counts by a Kalamazoo County Jury. Sentencing is scheduled for 11/29/93. On that day, Neilly will have been jailed 172 days.

Co-defendants Wogoman and Burnett have also been convicted and are awaiting sentencing. Brown is still awaiting trial.

VICTIM IMPACT STATEMENT:

Victim's impact statements from the deceased survivors are attached.

OFFENDER'S VERSION OF THE OFFENSE:

When interviewed at the County Jail on 11/19/93, Neilly offered the following.

First of all, Neilly states he did not know the Rickett's youth. In the afternoon proceeding the shooting, Neilly states that he had finished his last day of the school year at the Intensive Learning Center. After leaving school, Neilly hung out with his cousin Angelo Burnett on the east side and got high smoking marijuana.

About 9:00 p.m. that night, the pair got with Telly Matthews. Matthews had a car. The three of them went to a Party Store and brought some Cognac. They then went back to the east side and met up with Brown and Wogoman. They continued to drink and smoke.

Offender's Version of the Offense Cont'd....

After a while, they decided to go to Wogoman's neice's house on the north side. They hoped to borrow some money from her to go to a dance. When they got to the neice's house on Hawley Street, Wogoman and Neilly went up on the porch. No one was home. Wogoman then left the porch and Neilly hesitated a few moments and then urinated. When he got back to the car, Neilly states everybody was out of the vehicle and talking about doing this to that. Respondent states that Brown said, "we should jack him for his sounds." Neilly and Brown then volunteered to do it.

Neilly states that he got his 9mm pistol out of the glove box. Neilly had brought the pistol for \$50 on the street. Neilly already had a sweatshirt on and pulled up the hood. Neilly is uncertain if Wogoman gave a pistol to Brown, but notes that Brown was armed with the .380 automatic.

Neilly and Brown walked up to the truck. Neilly walked around the vehicle and then back to the drivers side. Respondent states that Ricketts looked at him. Neilly thinks that Ricketts knew he was going to be robbed. Ricketts saw they were wearing hooded sweatshirts and thinks the victim saw him holding his gun.

Ricketts pulled away. At that point, both Respondent and Brown shot. They then got scared and he and Brown took off running. They met the other three in the car on Douglas Street. Telly then drove them to the Patwood Apartment Complex. For a while, they hung around in the parking lot. Then respondent, Brown and Matthews went back to the east side in the car. Wogoman and Burnett stayed at Patwood.

Once on the east side, Brown took off. Defendant and Matthews went to a girl's house where they met back up with Wogoman and Burnett. The four of them went to Concord Apartments on West Main. Neilly states that they all continued to get more paranoid. Neilly and Burnett called a cab and took it back to the east side. En route, police saw them. They both jumped out of the car. Police caught Burnett almost immediately. Neilly made it to his mother's home and she told him to surrender. He did and he has been in jail since.

Neilly expresses remorse for what he has done. He states that this started as a joke, became a robbery, and ended in a tragedy. He feels this would not have happened if he had not been drunk and high. Neilly states he buried his gun at Rockwell Park. He is willing to show police where the weapon is.

PRIOR CRIMINAL HISTORY:

Instant offense is Neilly's first adult conviction. Respondent states he has a juvenile record. Kalamazoo County Probate Court files reveal he was adjudicated 7/20/92 for Possession of Controlled Substance less than 25 grams. He had been caught with a bag of marijuana. He was placed on Probation. On 9/2/92, he was placed in the Intensive Learning Center after failing in regular high school. He was terminated from the juvenile system on 6/24/93 after his arrest for the instant offense.

RE: CHRISTOPHER D. RICKETTS IMPACT STATEMENT

I attended the preliminary hearing June 22, 1993 and I did not feel or see any remorse from the defendants. I truly believe in my heart these men had intentions to do great bodily harm, including murder and it happened to be our Christopher, he was in the wrong place at the wrong time. I can still see their faces. They have very little regard for themselves or life. I have never been afraid of my people or the area the crime happened in but the actions and nonchalant attitude of these men and their families as we walked from the parking lot to our cars made me lose trust and faith. I had in the past tried not to pass judgement and give the benefit of the doubt.

It is so very hard to put into words how I feel. There are so many reminders of Chris. I can hear him say "But Aunt Patty" when we would have a conversation. I miss our weekly luncheons with my mother and Chris at Rykse's and watching him consume the amount of food that kept him the jolly size he was. Knowing the routes he took and the stores he and we as well patronized makes it unbearable sometimes. When I drive up the driveway of my parent's home it's a constant reminder because his little red truck more often than not was parked in the garage or he was using my mother's towels to wash it and she was scolding him. But I also visualize his little red truck in the garage with the bullet holes through the rear tailgate, canvass top and through his blood stained seat. I can see it like I'm looking at a colored photo.

My father, his grandfather died in January, 1993 from complications after surgery and since that time Christopher had assumed a new role as man of the house and taking care of his 72 year old grandmother. My mother is numb, she tells me she does not understand this, "your father's death was merciful but this I will never get over". She has not been able to go into his room. She is now lonely even though I have only missed 2 days from visiting her since this heinous crime, but for her just knowing he was in the next room at night made her feel at ease. Christopher had lived with my parents his entire life. My husband brought him and my sister home from the hospital after he was born.

Christopher had spent the night Wednesday, June 9. He and my daughter, Sonya were very close. He let her drive his truck the last day of school to Portage Central and then later on dropped her off, Thursday, June 10 for a wedding rehearsal and that was the last time we saw him alive. Sonya could not sleep at home for several days. She is devastated.

Chris was kind and mannerly to mother and everyone he knew. He never back talked me or my husband. We all loved and still do love Chris and it is so hard to believe he is gone. He had so much going for him and so much to give.

When my mother and I greeted family and friends the afternoon of Christopher's visitation services, (my sister was so distraught and pending possible admission to the hospital was unable to attend the afternoon services) I was overwhelmed with the large number of friends Chris had, white and black, that came to pay their last respects. All I could do was to put my arms around each and every friend and hold them and weep as they wept silent tears.

There is no doubt in my mind that Chris would have been an asset to society but all that has been lost by men who obviously have NO value on life. It does not seem fair that they could get a second chance at life. Christopher hadn't begun to experience life because he was gunned down minding his own business. I know Michigan does not have the death penalty and I don't know if I could live with that but I do believe a crime of this nature deserves life in prison without parole. To have weapons and ammunition in ones possession while joy riding says their intentions were not good. I want to continue to believe in the judicial system and I can only hope and pray justice is served.

There is no way you could possibly know how we feel, but just imagine if it was your son, grandson or nephew, how would you feel?

Chris' death was needless. When faced with confrontation, he chose to leave rather than to confront the young men.


It makes no difference to me whether Mr. Neilley intended to scare Chris as was claimed during the trial or kill him. The Kalamazoo community awaits your sentence as an indication of our community's willingness to tolerate crime. If Mr. Neilley is not dealt with severely, I fear that a terrible message will be sent to our community. Not only is Mr. Neilley's future at stake, but also the future of many other young people in Kalamazoo, most notably those living in our more disadvantaged sections. A message should be sent that "if you play with fire, you will be burned".

Chris' death poses a different situation that many other killings. Chris was more than an innocent victim. When confronted with wrongdoing, he decided to leave.

I realize that your job is difficult and that you have many things to weigh. You can assist in reducing serious crime in Kalamazoo by making an example of Mr. Neilley when you sentence him. If any case requires that an example be made, this case presents such an opportunity because of the notoriety of the case and Chris' death, despite his decision to leave rather than confront Mr. Neilley and the others.


