Michelle M. Rick Judges The Court orders that the motion for immediate consideration is GRANTED.

The omnibus motion to dismiss the claim of appeal is also GRANTED as to all of these consolidated appeals. The May 21, 2021 order appealed from does not constitute an order denying governmental immunity under MCR 7.202(6)(a)(v) and, thus, is not appealable of right under MCR 7.203(A). As the trial court recognized, the gravamen of defendants' motion for summary disposition with regard to plaintiffs' inverse condemnation claims was not a claim of immunity from such constitutional claims but rather an assertion that plaintiffs did not adequately plead the inverse condemnation claims. Accordingly, in relevant part, the trial court's order constitutes an order denying a motion for summary disposition under MCR 2.116(C)(8) premised on failure to state a claim, not an order denying governmental immunity under MCR 2.116(C)(7). See *Blair v Checker Cab Co*, 219 Mich App 667, 670-671; 558 NW2d 439 (1996) (trial court properly considered motion for summary disposition under appropriate subrule despite motion being framed under another subrule).
